### Registration and Payment

A \$1,000 non-refundable deposit is required to hold your spot. The remaining balance is due 90 days prior to the date of departure. If registration for a Boot Camp is within 90 days of departure date, the entire cost of the trip must be paid at time of registration.

You can make your payments by check, a wire transfer (we can provide details) or credit card.

### Cancellation Policy

With the exception of \$1000 which is non-refundable due to our commitments and bookings with our foreign partners in India and Bhutan, the balance is subject to the following cancellation fees:

Himalayan Boot Camp is a division of INSARA Corp and any charges to guest for Himalayan Boot Camp tour may include the name INSARA Corp in invoices, billing statements or receipts.

Payment for any Himalayan Boot Camp tour constitutes traveler acknowledgement and acceptance of the terms and conditions stated in this document.

Himalayan Boot Camp reserves the right to cancel a tour if there are not enough participants. Himalayan Boot Camp reserves the right to cancel a tour to ensure the safety of its guests in the event of any State advisory warnings for any areas near Himalayan Boot Camps locations. In this event, liability of Himalayan Boot Camp would be limited to full refund of the fees paid by each traveler to Himalayan Boot Camp.

### **Limits on Responsibility**

Himalayan Boot Camp, its employees, officers, or agents do not own or operate any of the companies that provide goods or services for its Himalayan Boot Camp tours. It procures in India, lodging and hotel accommodations, ground transportation and food and beverages for Boot Camp tours only. Therefore all such persons and entities are independent contractors and Himalayan Boot Camp is not liable for any negligent or willful act of any person or entity belonging to any independent contractor or contractors.

In addition, Himalayan Boot Camp will not be held responsible for any injury, loss, death, inconvenience, or delay resulting from but not limited to acts of God or acts of war and/or terrorism, strikes or labor disputes, illness or disease, mechanical or other failure of any means of transportation such as aircraft, buses, cars, vans, taxis, trains, boats, or other means of transportation nor for any transportation delays.

Himalayan Boot Camp guests may be subject to certain risks related to adventure travel which include, but are not limited to, hiking, walking, climbing injuries and altitude sickness, the potential dangers of animals, inaccessibility to immediate medical attention and difficulty in evacuation from any remote locations in the case of a medical emergency. Himalayan Boot Camp will not be held responsible and passenger assumes all such risks with regard to these possibilities.

In the event of any State Advisory warnings against Himalayan Boot Camp locations where Himalayan Boot Camp decides to cancel scheduled Boot Camp to ensure the safety of its guests, the guest will be notified by a staff member of Himalayan Boot Camp and 100% of the fees will be refunded. Should guest still choose to travel, in spite of any travel advisory or warning, guest assumes all risk of property damage, personal injury or death that may arise out of the events like those advised or warned against.

In the event, traveler does not acquire all documents for the trip in time such as passports and/or visas and is unable to participate in scheduled trip, Himalayan Boot Camp will not reimburse any funds back to the traveler.
